**Relationships and Sex Education**

I am writing to you with regards to Relationships and Sex Education (RSE) at Hedingham School. RSE is one element of our student Personal Development programme, the purpose of which is to equip students with the knowledge they need to enable them to live safe, fulfilled and healthy lives.

Aside from your child's three sessions of personal development each week, which are delivered in form groups between 8.40 and 9.10, students will have a focus morning which explores more sensitive areas of RSE and their personal development.

Students in **Year 11** will have their RSE sessions during lessons 1-3 on 19 November where they will explore information about topics including:

- **Harmful content on the internet.**
- **The law surrounding consent.**
- **Contraception. Understanding different types of STIs.**

Some parents prefer to take the responsibility for aspects of this element of education. They have the right to withdraw their children from all or part of the relationships and sex education except for those parts included in the statutory National Curriculum (i.e. in Science lessons) or in subjects where apparently unrelated topics lead to a discussion on aspects of sexual behaviour. We would make alternative arrangements in such cases. The request to withdraw must be made in writing to the Headteacher.

Parents are welcome to review any RSE resources the school uses and are encouraged to discuss their decisions with staff at the earliest opportunity.
